### ACER FEES

Pursuant to Commission Decision (EU) 2020/2152 on fees due to the European Union Agency for the Cooperation of Energy Regulators (ACER) for collecting, handling, processing and analysing of

information reported under Regulation (EU) No 1227/2011 of the European Parliament and of the Council (REMIT), wholesale energy market participants using RRM systems shall be charged with fees.

The level of the applicable fees for the market participants are determined by ACER.

Reporting of data to ACER about standard contracts executed on organized marketplace is subject to fees set by ACER. Based on internal GET Baltic decision ACER fee for reporting standard contracts executed on organized marketplace for the year 2021 shall be covered by GET Baltic. The ACER fee shall be collected starting from the year 2022. Following fees set by ACER shall be charged:
